## White Tiger Concludes Exploration Agreement with Aroland and AZA First Nations for its Marshall Lake Property Project, Ontario

**West Vancouver, British Columbia – August 9, 2012 –** White Tiger Mining Corp. (the "Company" or "White Tiger") is very pleased to announce that it has concluded an Exploration Agreement with the Aroland First Nation ("Aroland") and the Animbiigoo Zaagi'igan Anishinaabek First Nation ("AZA") in connection with the Company's Marshall Lake copper, silver, and gold exploration property project located 30 km west of Nakina, Ontario.

The Exploration Agreement will cover the entire mineral exploration phase of the Company's Marshall Lake property project. In accordance with the Exploration Agreement, White Tiger has agreed to provide certain financial payments and other benefits and to provide employment and service related opportunities to Aroland and AZA, and in return, Aroland and AZA have agreed to support the exploration of the Marshall Lake property. The Exploration Agreement also provides for the proper handling and protection of any possible burial or other culturally significant sites, and as well, includes plans for the prevention, mitigation and remediation of any and all environmental impacts which may result from the project in accordance with all applicable laws respecting environmental protection.

Chief Sonny Gagnon of the Aroland First Nation states, "Aroland First Nation takes pride in the fact that we are working with industry to both ensure respect for our aboriginal and treaty rights, and to secure mutual benefit and capacity development from such arrangements."

Chief Yvette Metansinine of the Animbiigoo Zaagi'igan Anishinaabek First Nation states, "this agreement reflects a progressive, mutually respectful relationship. This demonstrates that industry and First Nations can work together when the right steps are taken and respect is shown for our lands and rights. We are very pleased with this."

Douglas Mason, Chief Executive Officer of White Tiger Mining Corp. states, "White Tiger is extremely pleased to have been able to conclude a favourable Exploration Agreement with the Aroland and AZA First Nations and we believe that this Agreement will bring economic opportunities to the region and will provide certainty for the Company's Marshall Lake property project in a manner which is respectful of Aroland's and AZA's traditional territories and their aboriginal and treaty rights."
