REMSENSE CONTINUES EXPANSION WITH TIER 1 OIL & GAS MAJOR

RemSense Technologies Limited (ASX: REM) (RemSense or the Company) is pleased to announce that it has received a further project award, via its strategic partner Applus Pty Ltd (**Applus+**), for the delivery of RemSense's virtualplant asset intelligence application at an offshore platform operated by a Tier 1 Oil & Gas major.

The award represents the third facility under this program to be captured using RemSense's advanced digital asset visualisation technology.

The continued expansion of the program across additional offshore facilities reflects increasing adoption of virtualplant as a scalable platform for remote asset visualisation, digital inspection, maintenance planning and engineering support across complex offshore operating environments.

Project Overview

Under this latest agreement, RemSense working in partnership with **Applus+** will deliver ground and drone-based ultra-high resolution imagery capture, processing and delivery via virtualplant for the facility.

The project includes:

- Aerial and terrestrial ultra high-resolution LiDAR scanning, advanced 360-degree photogrammetry.
- Creation of an enhanced **virtualplant** visual twin to support Remote Digital Visual Inspections (RDVI), maintenance planning and engineering workflows, etc.
- Ongoing virtualplant access and subscription services to enable Applus+ and Tier 1 Oil & Gas major teams across Australia to collaborate in real time.

The total contract value is A\$153,750 with work scheduled to be completed in July 2026.

Repeat Award Reinforces Strategic Growth with Tier 1 Energy Operators

This latest award builds on RemSense's growing relationship with Applus+ and further validates the Company's strategy to secure repeatable, high-value engagements with global energy operators.

The award of a third facility demonstrates the scalability of virtualplant across offshore oil and gas assets and supports RemSense's objective of establishing its platform as a trusted digital visualisation solution for Tier 1 energy and resources companies.

By creating highly detailed, cloud-based visual twins of operating assets, virtualplant enables customers to reduce the need for site visits, improve asset integrity workflows,





support safer planning and inspection activities, and provide teams with a consistent source of visual asset information.

Strategic Importance

RemSense considers the expansion of virtualplant across a third facility to be an important milestone in demonstrating the platform's capability to support digital transformation initiatives across complex and high-value industrial environments.

There are no material terms or conditions precedent requiring satisfaction to enable the contract works to be fulfilled, and there are no terms or conditions to the contract considered outside of normal commercial terms and conditions, including termination clauses.
