## Aurum hits 150 g/t gold at Boundiali, Côte d'Ivoire

Aurum Resources (ASX: AUE) reports further exceptional high-grade gold intercepts from its 1.59Moz Boundiali Gold Project in Côte d'Ivoire.

### Highlights

- Exploration diamond drilling (17 holes for 4,550m) targeting multiple prospects on the Boundiali **BM** tenement returns shallow, wide and high-grade gold hits<sup>1</sup> including:
  - **1m @ 150.50 g/t Au** within **3m @ 50.56 g/t Au** from 124m (MBDD130)
  - **2m @ 63.55 g/t Au** from 111m inc. **1m @ 110.95 g/t Au** & **23m @ 2.04 g/t Au** from 118m (MBDD123)
  - **1m @ 9.28 g/t Au** from 65m & **1m @ 58.39 g/t Au** from 71m (MBDD121)
- These results demonstrate the emerging potential and continued upside of the Boundiali project, with mineralisation remaining open along strike and at depth.
- Aurum's six self-owned diamond rigs **continue to drill** at Boundiali with **100,000m** targeted in CY2025
- **Two MRE updates** planned in **CY2025** to grow the maiden **1.59Moz Boundiali Mineral Resource Estimate**<sup>2</sup>
- Aurum's takeover of Mako Gold (ASX: MXG)<sup>3</sup> **moves to compulsory acquisition** – the merged company has **2.47Moz** of gold resources and aggressive cost-effective drilling is planned to drive resource growth
- **Aurum is well-funded**<sup>4</sup> (~\$23M cash at bank) for continued exploration success.

**Aurum's Managing Director Dr. Caigen Wang** said: *"I am excited to announce new shallow high-grade gold intercepts at our Boundiali project. Drilling at the BM Target 3 (BMT3) continues to deliver with MBDD130 intersecting **1m @ 150.50 g/t Au** within **3m @ 50.56 g/t Au** and MBDD123 returning **2m @ 63.55 g/t Au**, including **1m @ 110.95 g/t Au**. These results reinforce the exceptional potential of BMT3, which already boasts a project-best intercept of **1.19m @ 277.54 g/t Au** from hole MBDD118, and we remain confident that similar intercepts are foreseeable.*

*Importantly, these latest hits will be included in the next Boundiali Mineral Resource Estimate (MRE) update expected in the first half of this year. This update will build on Boundiali's current **1.59Moz MRE** and incorporate results from our ongoing 100,000m diamond drilling campaign in 2025. We expect another resource update in the second half of this year, including results from drilling at the BD, BM, and BST deposits, as well as numerous untested gold-in-soil anomalies. Our exploration efforts are aimed at delivering significant resource growth at Boundiali in 2025 and beyond, ultimately feeding into a Pre-Feasibility Study (PFS) expected at the end of the year.*

*At our Napié project, we're planning an aggressive 30,000m diamond drilling program in 2025 to expand the current **0.87Moz MRE**<sup>5</sup>. An updated MRE for Napié is expected by year-end.*

*This is an exciting time for Aurum shareholders. With a combined **2.5Moz** of gold across Boundiali and Napié, and a substantial drilling program planned for both projects, we are well positioned for significant resource growth and further value creation in 2025.”*

#### **BM - Latest Drill Results**

Aurum reports results for 17 holes for 4,550m of diamond core drilled at its BM tenement including at **BM Target 1** (2 holes for 938.50m) and **BM Target 3** (15 holes for 3,611.50m), part of an expanded drill program at **BM** where Aurum holds an 80% project interest<sup>6</sup>.

Aurum's geologists used information from previous drilling and field mapping to identify these prospects, which include some large artisanal pits. **BM Target 3 NW** has delivered project best intercept (**1.19m @ 277.54 g/t Au** from 31m, MBDD118). True widths for these shallow wide and high-grade gold intercepts are estimated at about 70% - 80% of reported downhole lengths.

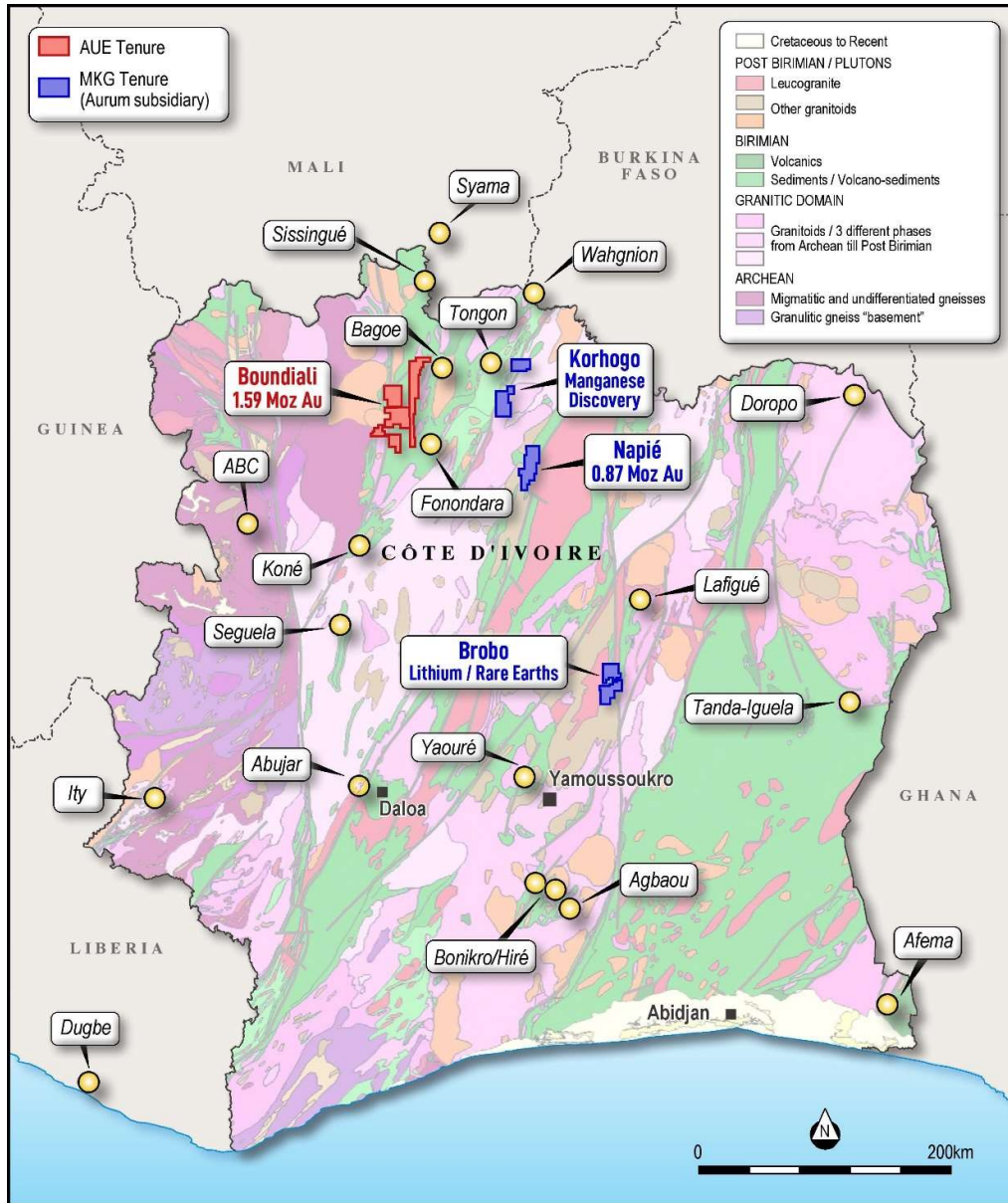


Figure 1: Location of Aurum's projects in Côte d'Ivoire



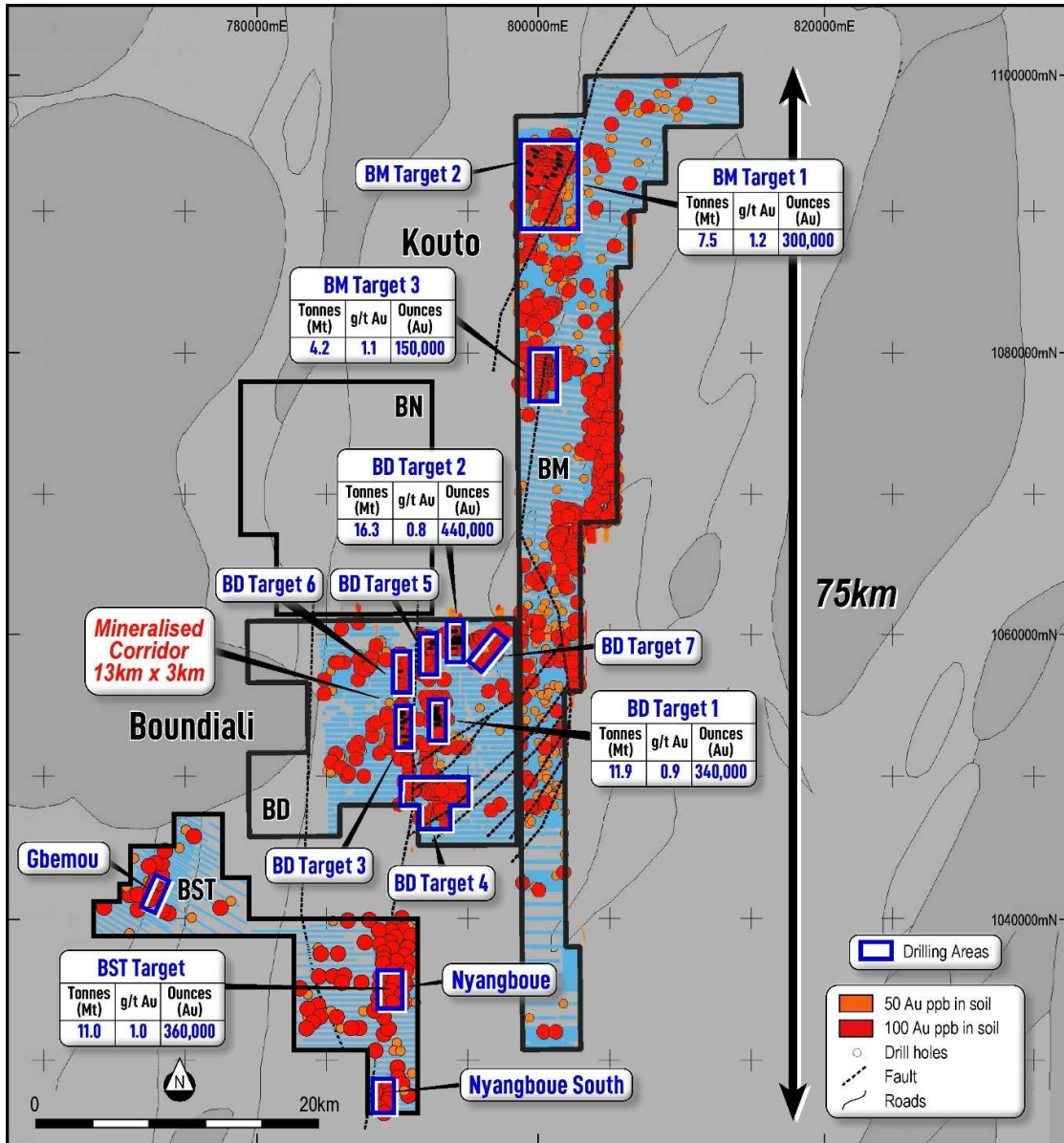


Figure 2: Aurum's Boundiali Gold Project

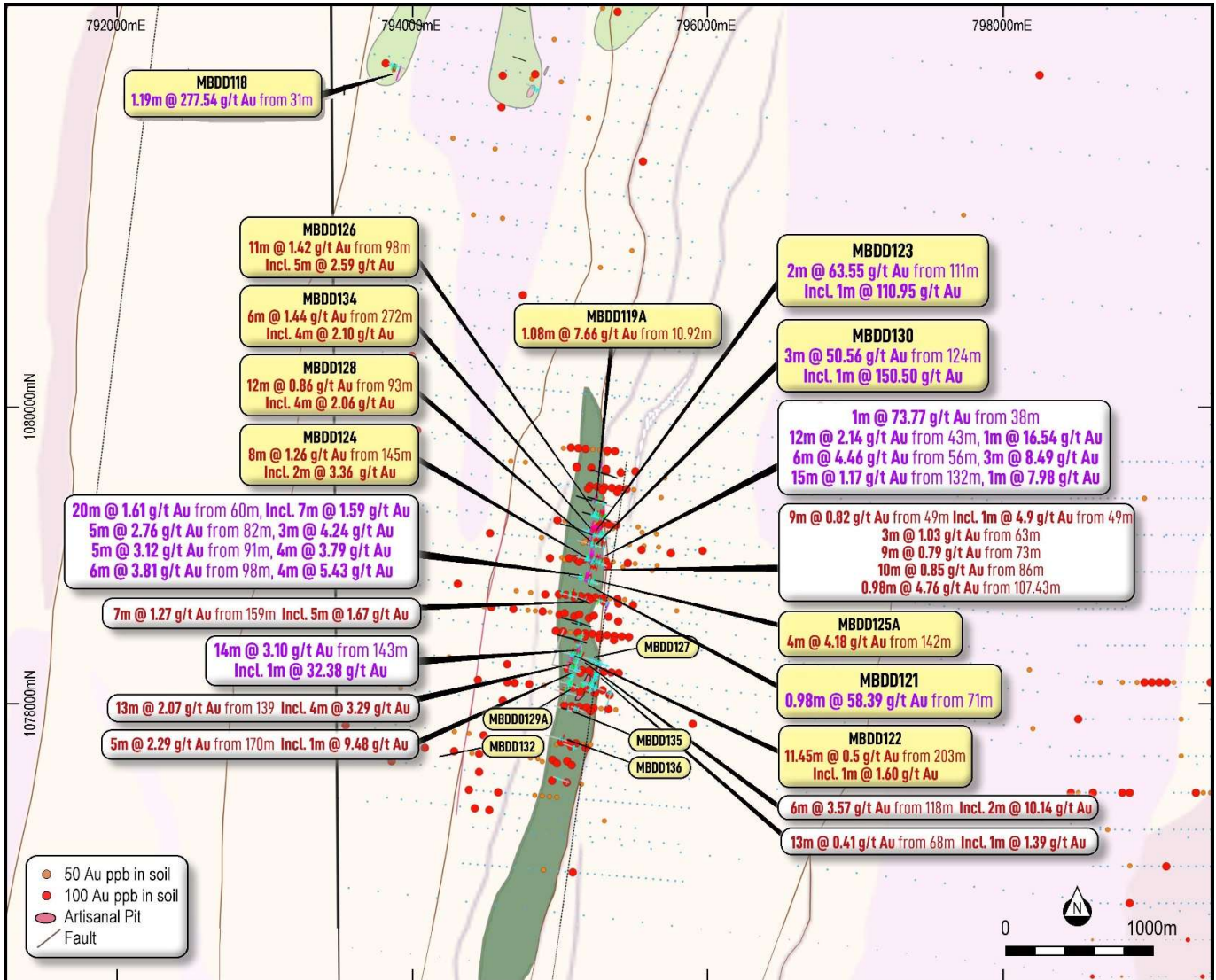


Figure 3: BM tenement plan view showing new significant drilling results (yellow) at BM Target 3



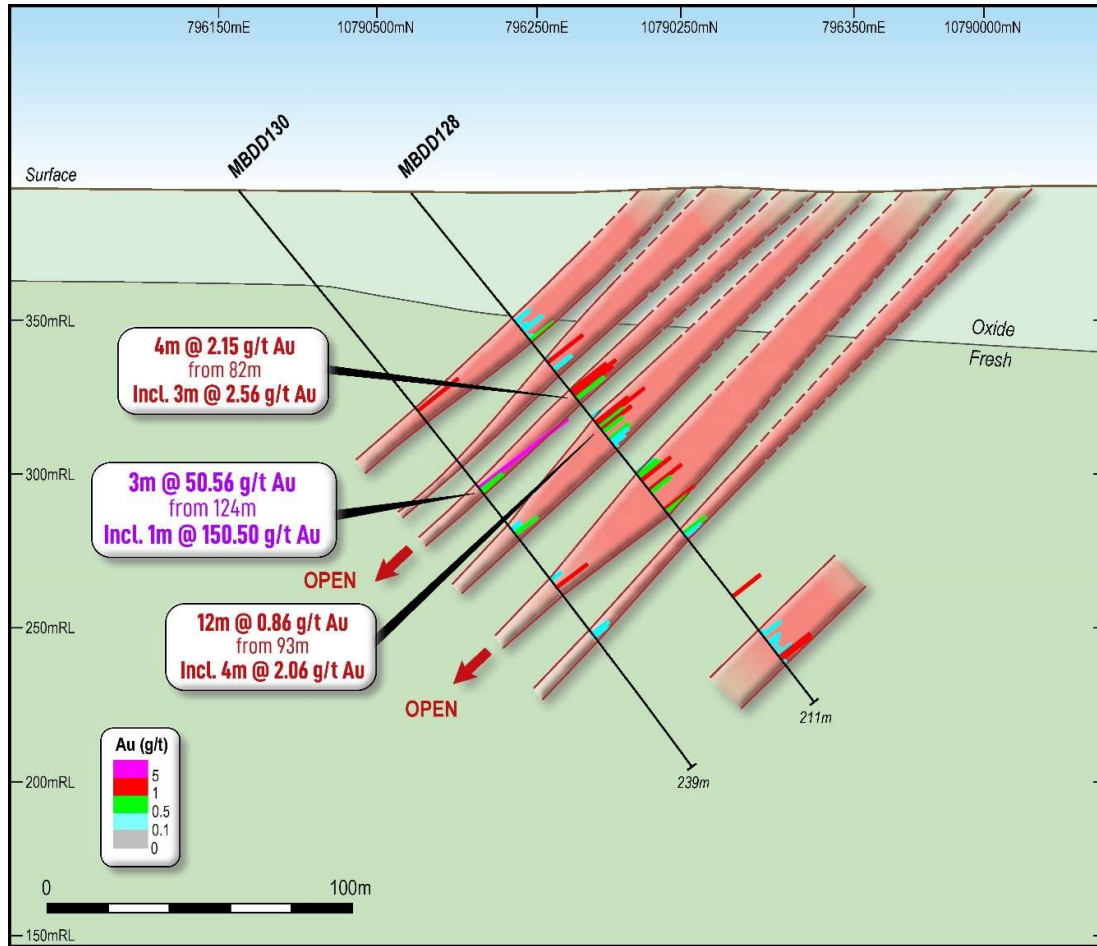


Figure 4: Oblique Cross Section looking northeast (+/-50m) showing new drill results MBDD130 – BM Target 3

Details of drill collar location and assay results for the new drilling at **BM** can be found in **Table 1** and **Table 2** respectively. Plans showing location of the Boundiali Gold Project and the assay results are presented in figures below (general locations in **Figure 1** and **Figure 2** and a detailed plan in **Figure 3**). A cross section showing the latest drill results is presented in **Figure 4**.

Gold mineralisation remains open along strike and at depth on all prospects, with drilling ongoing and Aurum is planning further work to follow up these initial results.

### **Boundiali – 100,000m drill program**

Aurum is planning an extensive 100,000m diamond drilling program in 2025 at its 1.59Moz Boundiali Gold Project in northern Côte d'Ivoire. The program<sup>9</sup> has multiple aims: to increase the size and confidence of current resources at BST, BD, and BM (40,000m), and to advance known prospects (30,000m) for incorporation into two planned resource updates in 2025. Additionally, about 30,000m of drilling will target new prospects identified through soil anomalies and geological mapping to drive resource growth into 2026.

### **Next Steps:**

- **Aggressive Cost-effective Exploration at Boundiali:** Aurum is committed to a large-scale exploration program at Boundiali. This includes:
  - **100,000m Diamond Drilling:** Six diamond drill rigs will complete 100,000m of drilling at Boundiali in CY2025.
  - **Resource Expansion:** Drilling will expand the known resources at the BST, BD, and BM deposits.
  - **New Discoveries:** Exploration and scout drilling is planned on BM, BM and BST tenements to test new targets and create a pipeline of new discoveries to flow into resource growth.
- **Resource Updates:** Aurum plans to deliver two MRE updates for Boundiali in CY2025.
- **Napié Project Development:** A 30,000m diamond drilling program is planned for the Napié project in CY2025 to expand the existing 0.87Moz resource. An updated MRE for Napié is expected by year-end.
- **Pre-Feasibility Study:** Aurum is working towards completing a PFS for the Boundiali Gold Project by the end of CY2025. This will provide a more detailed evaluation of the project's economics and technical feasibility.
- **Continued Growth:** With a strong financial position (~\$23M cash at bank at the end of December 2024), Aurum is well-funded to execute these exploration and development plans. The company remains focused on delivering value for shareholders through resource growth and project advancement.

## **Aurum's takeover of Mako Gold Limited**

On 24 January 2025, Aurum advised that with a relevant interest in 90.23% of Mako shares, it would proceed to compulsory acquisition and the ASX will suspend quotation of Mako shares in accordance with ASX Listing Rule 17.4. Aurum launched its takeover bid on 16 October 2024 and the offer will close on 31 January 2025 at 7.00pm (Sydney time).

## Boundiali Gold Project (1.6Moz)

The flagship 1.6Moz Boundiali Gold Project is comprised of four neighbouring exploration tenements and is located within the same greenstone belt as Resolute's large Syama (11.5Moz) gold mine and Perseus' Sissingue (1.4 Moz) gold mine to the north and Montage Gold's 4.5Moz Koné project located to the south. Barrick's Tongon mine (5.0Moz) is located to the northeast (Figure 1):

- 1) Boundiali Minex Tenement PR0893 ("**BM**"), 400km<sup>2</sup>, holder Minex West Africa, of which Aurum holds 80% (through its fully owned subsidiary Plusor Global Pty Ltd "Plusor") and can hold interest of between 80-88% in a mining licence.
- 2) Boundiali DS tenement PR808 ("**BD**"), 260km<sup>2</sup>, holder DS Resources Joint Venture Company, of which Aurum is 80% share capital owner through its fully owned subsidiary Plusor.
- 3) Boundiali South tenement PR414 ("**BST**"), 167.34km<sup>2</sup> is located directly south of Aurum's **BD** and **BM** tenement. The **BST** exploration tenement was renewed on 19<sup>th</sup> August 2024. Predictive Discovery Côte d'Ivoire SARL (89% owned by Turaco Gold Limited and 11% owned by Predictive Discovery Limited) agreed to sell 100% interest to Aurum, subject to Aurum obtaining a renewal of the Boundiali South tenement (or the granting of a replacement tenement) and being satisfied that the terms of the renewal (or replacement) do not restrict exploration or potential future mining rights, along with all required Government approvals.
- 4) Boundiali North tenement PR283 ("**BN**"), 208.87km<sup>2</sup>, under renewal, Aurum to earn up to 70% interest through its wholly owned subsidiary Plusor.

### BM gold project JV

Mako Gold (majority owned subsidiary of Aurum) entered into a farm-in and joint venture agreement on the Napié Permit with Occidental Gold SARL, a subsidiary of West African gold miner Perseus Mining Limited (ASX/TSX:PRU) in 2017<sup>13</sup>. Subsequently Mako renegotiated the agreement with Perseus and

has consolidated its ownership in the Napié Project from 51% to 90%<sup>14</sup>. In addition, Mako Gold has 100% ownership of the Korhogo Project (significant manganese discovery<sup>15</sup>) and the Brobo Project (lithium/rare earths).
