# \$2.5M PLACEMENT TO FUND EXTENSIVE GOLD DRILLING AT LEINSTER SOUTH

## Highlights:

- \$2.5 million private placement at \$0.41 per share
- Placement completed at a premium to the last closing price of \$0.395
- Metal Hawk will use the funds to advance gold exploration at Leinster South as it heads towards an extensive maiden drilling program at the Thylacine and Siberian Tiger prospects

Metal Hawk Limited (**ASX: MHK**, "**Metal Hawk**" or the "**Company**") is pleased to announce that it has received firm commitments from sophisticated investors to raise A\$2.5 million by way of a private placement (the "**Placement**").

Proceeds from the Placement will be used to fund gold exploration activities including an extensive maiden drilling program at the Leinster South Project in Western Australia.

#### **Placement Details**

The \$2.5 million Placement (with no costs) will comprise a total of 6,097,561 new fully paid ordinary shares ("**New Shares**") at an issue price of \$0.41 per share. New Shares are to be issued pursuant to the Company's placement capacity under ASX Listing Rule 7.1A.

Completion of the Placement is expected to occur on or around 26 March 2025.

The Placement issue price of A\$0.41 per New Share represents; a 3.8% premium to the closing price of Metal Hawk shares of A\$0.395 on 20 March 2025 (being the last trading day prior to the Placement); and a 7.5% premium to the 10-day VWAP prior to the Placement.

**Metal Hawk Managing Director Will Belbin commented:** *"We are very pleased with the strong level of support from our current shareholders. The proceeds of the Placement together with existing cash reserves puts Metal Hawk in an excellent position ahead of the upcoming maiden drilling program at Leinster South."* 

"Thylacine and Siberian Tiger are two of the most exciting untested high-grade gold prospects in the Goldfields. In addition to an extensive drilling campaign, we are also looking forward to ramping up our regional exploration efforts."

## **GOLD DRILLING SCHEDULED TO COMMENCE IN Q2 2025**




Figure 1. Leinster South main gold prospects and rock chip results

Metal Hawk recently discovered high grade gold at the Leinster South project, located along the eastern limb of the Lawlers Anticline. Mapping and geochemical sampling has identified high grade outcropping gold at several untested prospects (see Figure 1). Metal Hawk is progressing towards a maiden drilling program at the Thylacine and Siberian Tiger gold prospects following a heritage clearance survey scheduled for Q1 2025.




Figure 2. Metal Hawk's Leinster South Project location
