



## SEPTEMBER 2025 QUARTERLY ACTIVITIES REPORT

Cyprium Metals Limited (**ASX: CYM / OTCQB: CYPMF**) (**Cyprium** or the **Company**), a copper developer focused on the phased restart of the Nifty Copper Complex in the Paterson region of Western Australia (**Nifty**), is pleased to report its quarterly activities for the period ended 30 September 2025 (**September Quarter**).

### HIGHLIGHTS

- **Transformational A\$80 million capital raise** via Placement and Entitlement Offer to fund the Phase 1 Cathode Project restart at the Nifty Copper Complex. Capital raise was completed post quarter-end
- **Cyprium fully funded to execute the Phase 1 Cathode Project**, materially strengthen the balance sheet, complete the feasibility study for the Concentrate Project and maintain the Company's extensive asset base in the Paterson Province
- **Continued progress payments on surplus generator sale:** Additional US\$2.4M received from the sale of surplus generators in the September Quarter, with final payment of US\$1.2M remaining
- **Director Appointments announced post quarter-end:** Jim Simpson and Amber Banfield to join the Board (subject to election at the late-November AGM); Ross Bhappu to retire
- **1-for-10 Share Consolidation** approved by shareholders post quarter-end
- **Strong cash position:** A\$24.5M cash at quarter-end with further A\$62.8M cash received post quarter-end (Tranche 2 Placement & Entitlement Offer proceeds)

**Commenting on the September Quarter, Cyprium Executive Chairman, Matt Fifield, said:**

*"This quarter we put the pieces in place to restart copper production at Nifty. With the funding advanced our focus is quickly shifting to execution: finalising key contracts, placing long-lead orders, and commencing site activities for the cathode restart. This is a busy and exciting time for the Company."*

## FUNDING UPDATE

### A\$80 million capital raise via Placement and Entitlement Offer

In August, Cyprium announced an A\$80 million capital raise comprising a A\$74 million two-tranche Placement and a fully underwritten A\$6 million Entitlement Offer at an issue price of A\$0.028 per share.

The Placement was strongly supported by new and existing institutional shareholders and Cyprium's Board of Directors. More than 20 new and existing Australian and international institutional shareholders participated in the Placement.

The issue price of A\$0.028 per share represented a 6.4% discount to the 10-day VWAP prior to the capital raise.

Proceeds of the A\$80 million (before costs) capital raise to be used to execute the phase one Cathode Project, materially strengthen the balance sheet, complete the feasibility study for the Concentrate Project and maintain the Company's extensive asset base in the Paterson Province.

The Placement and Entitlement Offer was completed in the following tranches:

- Tranche 1 of the Placement was completed on 3 September 2025, raising approximately A\$14.5 million (before costs) via the issue of 515,931,656 new shares.
- The Entitlement Offer was completed on 1 October 2025 (post quarter-end), raising approximately A\$6.0 million (before costs) via the issue of 214,969,893 new shares.
- Tranche 2 of the Placement was completed on 17 October 2025 (post quarter-end), raising approximately A\$59.6 million (before costs) via the issue of 2,126,925,510 shares. Tranche 2 was completed following receipt of shareholder approval at an Extraordinary General Meeting (EGM) held on 13 October 2025.

## PROJECTS UPDATE

### Nifty Copper Complex – Phase 1 Copper Cathode restart fully funded

Securing funding was the primary focus of the September Quarter. Cyprium continued to advance its phased restart strategy for the Nifty Copper Complex by progressing environmental compliance works on site through refurbishment and upgrade of the W-drains adjacent to the heap leach pads.

#### Cathode Restart Project

Cyprium and Macmahon continued to progress operational readiness workstreams for the cathode restart project. Key workstream are well progressed, and include:

- Detailed project execution planning
- Project delivery master schedule and critical path identification
- Long lead items procurement schedule and processes
- Health, Safety, Environment and Quality Management Systems
- Project delivery risk assessments
- Project controls and governance systems
- Identification, engagement and recruitment of key personnel and consultants

Negotiation with Macmahon of formal construction and operations contracts for delivery of the cathode restart project are well progressed.

## Open-pit Mining and Concentrate Project

Workstreams continue with a focus on optimising the open-pit mine plan, pre-strip sequencing, and leveraging brownfields infrastructure already on site to improve capital intensity and schedule confidence.

## Maroochydore Copper-Cobalt Project

The Company continues to examine the potential for the Maroochydore Copper-Cobalt deposit to provide ore feed into a Paterson hub and spoke processing model using the existing Solvent Extraction & Electrowinning (SXEW) plant and sulphide concentrator at the Nifty Copper Complex.

## Paterson Exploration Project

Cyprium is evaluating recently received exploration data from IGO following their A\$24 million invested for the period 2020 – 2025. This information was acquired by IGO during their tenure as manager of the Paterson Exploration Project joint venture and transferred to Cyprium following the termination of that joint venture. Activities during the quarter included:

- **Data acquisition:** Transfer of data from IGO to Cyprium was finalised; transfer of physical assets (drill core, drill chips, sample pulps) is scheduled for Q4 CY25
- **Data integration:** Consultants engaged to review, integrate and evaluate extensive geophysical data sets acquired by IGO during the term of the joint venture
- **Data review:** Ongoing data review has highlighted the Rainbow Prospect and NL05a targets as priorities for the company

Field visits to Rainbow and NL05a are planned in Q4 CY25, with drill testing of NL05a scheduled to commence before the end of CY25.

## Cue Project

Drilling and downhole geophysics at the Heeler and Eelya South Prospects planned during the September Quarter. Cyprium intends to commence these exploration activities in CY26. The Company continues to review its longer-term plans for the Cue Copper Project.

## CORPORATE UPDATE

### Share Consolidation

In August, the Company announced its intention to consolidate the share capital of Cyprium via a 1-for-10 share consolidation. The Company believes that the share consolidation will result in a more appropriate and effective capital structure for the Company and will result in a share price more appealing to a wider range of investors.

Shareholder approval for the share consolidation was received at an EGM held on 13 October 2025. Trading of Cyprium securities on a post consolidation basis commenced on a deferred settlement basis on 28 October 2025.

## Director Appointments

Post quarter-end, Cyprrium announced the appointment of two highly skilled Non-Executive Directors, Jim Simpson and Amber Banfield. Mr Simpson and Mrs Banfield will join Cyprrium's Board of Directors following approval of their respective elections as directors by the shareholders of the Company at the upcoming Annual General Meeting in late November. Current Non-Executive Director Ross Bhappu will retire at the conclusion of the same meeting.

## Continued Payments from Asset Sales

The Company received further incremental payments for the sale of surplus generators in the September Quarter. Total payments received to date is US\$5.2 million (A\$8.0 million). The final remaining payment of US\$1.2 million (~A\$1.8 million) is expected in early-November as certain milestones relating to logistics and export are met.

## FINANCE UPDATE

With the conclusion of the A\$80m capital raise, Cyprrium is funded to bring Nifty's cathode operations online to generate meaningful cash flow and to further consolidate the Company's balance sheet. Expenditures during the September Quarter focused on maintaining an active mine site under regulatory requirements and progressing project readiness workstreams for the transition from development stage to operations.

## Cash Flows from Operating Activities

Net cash used in operating activities in the September Quarter of A\$7.7m includes:

- A\$1.0m salary expenses relating to Nifty on-site staff and the Cyprrium management team
- A\$3.1m for site operations
- A\$1.3m on administration and corporate activities
- A\$2.4m on interest on borrowings and convertible notes; partially offset by
- A\$0.1m of interest received on savings and term deposit accounts

Payment of A\$170,000 reported in item 6.1 of the attached Appendix 5B relates to payments to the Executive Chairman and Non-Executive Directors (including superannuation).

## Cash Flows from Investing Activities

Net cash provided by investing activities in the September Quarter of A\$2.7m includes:

- A\$3.5m net proceeds from disposal of property plant and equipment. This is primarily driven by the proceeds from the progress payments in relation to the surplus generator sale (as noted above): and
- A\$0.1m proceeds from sale of other non-current assets; partially offset by
- A\$0.4m net payments to acquire property plant and equipment; and
- A\$0.5m net payments for exploration and evaluation.

## Cash Flows from Financing Activities

Net cash provided from financing activities in the September Quarter of A\$15.8m includes:

- A\$14.5m proceeds via issue of securities in relation to Tranche 1 of the two-tranche A\$74m Placement and A\$2.7m of proceeds received with respect to the A\$6m Entitlement Offer. The

balance of proceeds from the two-tranche Placement and Entitlement Offer were received post the quarter-end; partially offset by

- A\$1.3m transaction costs related to the above issue of equity securities; and
- A\$0.1m repayment of borrowings related to leases.

## Cash and Liquidity

As of the end of the September Quarter, the Company had A\$24.5 million of cash on hand. Subsequent to 30 September 2025, the Company successfully completed Tranche 2 of the Placement and the Entitlement Offer, receiving additional proceeds of A\$62.8m (before costs).

## Looking Ahead – December Quarter and Beyond

In the December Quarter, Cyprium will focus on:

- Delivery of the phase one Cathode Project restart
- Completion of early works and long lead items for the Cathode Project
- Continued work on the restart of the open pit
- Completing strategic review of Paterson Exploration Project
- Maximising capital market engagement around the Cathode Project restart
- Completing the generator sale

With the phase one cathode restart funding secured, a strong balance sheet, and copper prices supportive, Cyprium is well-positioned to execute its value-accretive phased restart strategy at the Nifty Copper Complex and drive exploration upside across its Tier-1 copper portfolio.

We look forward to updating shareholders as we progress against our clear forward work plan.
