### SHARE PURCHASE PLAN

Horizon Minerals Limited (ASX: HRZ) (“Horizon Minerals” or “the Company”) is pleased to confirm that the offer period for the Share Purchase Plan (Offer) is open from today, Wednesday 26 February 2026.
